If the dispute is not resolved through mediation, then arbitration will apply. ARBITRATION MUST BE ON AN INDIVIDUAL BASIS. The arbitration shall be conducted in Dallas, Texas, by one neutral arbitrator chosen by the AAA according to its Commercial Arbitration Rules. Except where prohibited by law, by participating, you agree that any and all claims, judgments, and awards shall be limited to actual out-of-pocket costs incurred, including costs associated with entering this Alcuin School Raffle.
